## Chair's Message

Dear Riverina branch members,

I hope that you will have an equally successful 2015 as the last year with good attendances in CPD functions, and with relative policy stability in our professional sector. However, this year is likely to bring some major challenges for our profession that may require proactive consideration and Branch input.

- 1) We already had the 4+2 training program PsyBA consultation process that closed on 27th of February. Our branch has provided a separate submission under the names of the 4+2 working party, and provided constructive input to the APS submission.
- 2) The DGPP seems to be still struggling to get its own identity and website. The NSW section of the DGPP is currently looking for a second representative. I hope this position will soon be filled and DGPP will have its own website.
- 3) The impact of the trial roll out of the NDIS had a serious negative impact on the employment of psychologist within this sector. The changes at the Newcastle trial site is likely to result in job losses for psychologist employed with NSW-ADHC.
- 4) The federal government will soon be releasing the Commonwealth Mental Health report. It would not be unreasonable to assume that this report will shape future Commonwealth mental health policy and directly influence the 2015 federal budget allocations for the mental health sector.
- 5) The change of Medicare Local to Primary Health Networks (PHN) will also pose new challenges to service provisions and employment of psychologists, especially since the role of the new PHNs are not directly responsible for the provision of services.
- 6) At the NSW level, I strongly suggest that you read the Mental Health Commission of NSW- Living Well- A strategic plan for mental health NSW 2014-2024 http://nswmentalhealthcommission.com.au/. This report provides the reader with some insight into the local challenges for our profession and mental health services in general.



As you can see, challenges come from both the federal and state governments. At the time of writing this letter, I am not aware of any proposed policy changes or policy details from both the federal and state governments. However, the APS will keep you posted through the website, newsletters and APS mail-outs like APS Matters.



On a lighter note, we recently had our Meet & Greet function. This social gathering apart from being a great opportunity to meet up with peers gave me an opportunity to share with you important developments from my attendance of the recent state committee and branch chair forum meetings.

Finally, we are working through the recent CPD survey to plan for our 2015 local training program. I hope you we can accommodate your wishes within the current Branch constraints.

I wish you a great autumn season and I hope I will see all of you at our CPD events.

## Report on recent membership survey regarding branch committee meeting minutes

At the 'Meet and Greet' function some members asked if the committee meeting minutes could be distributed to the members. Consequently, the question was asked as part of a broader survey to all 87 branch members.
