1) Journal of Telemedicine and Telecare (JTT). An academic journal that is relevant to the work of telephone and internet counselling...

JTT has been defined in general terms to be 'medicine & therapy practiced at a distance' and as such it encompasses diagnosis and treatment, as well as education. During the last decade certain telemedicine applications, such as videoconsulting and teleradiology, have matured to become essential health-care services. Others, such as telepathology, remain the subject of intensive research effort. The *Journal of Telemedicine and Telecare* is an academic journal that publishes peer-reviewed papers on all aspects of telemedicine and telecare, including online health and e-health. 2) NSW Health research grant- Helplines Australia has secured a grant to identify aspects of telephone counselling and skills required to make the counselling effective via this medium.

The grant has been re-negotiated and will be due to commence in August 2006. We will require input from Psychologists and APS members and this will take place later in the year. We also anticipate that this research grant will form the platform for revising the Guide to best practice 3rd edition for helplines.
