Report of the Chair, PAIG AGM, 2010

Psychology and Ageing Interest Group Members-

I am happy to report that in 2009-2010 the National Psychology and Ageing Interest Group continued to quietly gain members and sponsor important initiatives. We are continuing to support efforts to facilitate psychology postgraduate trainees working in residential aged care settings. This

follows a number of position statements and appeals to government to try to improve access for persons in RACFs to psychological care.

Ageing also continues to rise in prominence within the APS and its publications. Healthy ageing featured as a topic for Psychology Week a few years ago, and in 2008 the cover story of InPsych featured the role of psychologists in nursing homes. This issue generated quite a bit of interest across the country. In 2010 the trend continues with a cover story in InPsych about the role of psychologists in assessment and treatment of dementia.

Regarding conferences, 2009 was the gap year but next year we are gearing up again for our national conference. We are considering a number of venues and will keep members posted via email.

The group elected a new convenor, Carol Hunter, in May 2010, and would like to thank previous convenor Paul Kemp. Following a lengthy period of inactivity, PAIG SA has met on two occasions, June 2010 and August 2010.

In June, Chris Materne of Flinders University gave a presentation of her current research investigating memory self-efficacy and memory training interventions in individuals with a diagnosis of dementia. This was followed by a clinical case presentation with a focus on assessment of suicidal behaviour in the context of dementia.

The August meeting was well attended, with a presentation from Margaret Brown of the Hawke Research Institute on aspects of end of life care, including guardianship, and how to have those difficult conversations with clients.

There is a meeting scheduled for November 2010, with a presentation on ageing and suicide. In early 2011 we have a presentation on relationship difficulties in older couples.

We hope to continue to have regular meetings, with the key aim to provide useful and informative sessions for professionals working with older populations both clinically and in a research capacity. We hope to attract more members in 2011 and encourage participation and interest in working with older people.

This year the ACT APS-PAIG has continued to follow our ever-popular breakfast meeting format, hearing from different researchers and clinicians specialising in aspects of psychology and aging. In May, postgraduate student Prapti Gautam from the Australian National University's Centre for Mental Health Research gave a talk on her research concerned with structural and functional changes in the ageing brain, and the implications of these changes for cognition. In September we will hear from Dr Rajeev Kumar, Psychiatrist at The Canberra Hospital and senior lecturer at the ANU medical school, who will share clinical insights regarding assessment and treatment of depression in the medically ill and elderly. We are also looking forward to a presentation from Professor David Bunce of London's Brunel University later in the year. An expert in cognitive

neuropsychology, Professor Bunce will discuss his research concerned with the interface between mental health and cognition in later life.

The Victorian branch of the PAIG has had a busy year, and the three meetings held to date were well attended. Our May and September meetings had 20 or more attendees, due in part perhaps to our decision this year to vary the location of meetings. We conducted an online survey of members at the beginning of the year, which showed:

- Most members work in the field of ageing and are interested in keeping informed about the latest ageing news.
- In order of popularity, members reported to be most interested in healthy ageing, clinical psychological conditions (e.g. dementia or stroke), social issues (e.g. social participation) and aged care.
- There were some members who live further away from Melbourne, and found it more difficult to attend PAIG events. However, the vast majority of members listed the City, Swinburne and Hawthorn as the most convenient locations.
- While there was a slight preference for events to be held either at 6pm or 7pm (on any day), several members gave the useful suggestion to regularly change event times (e.g. have one event in the afternoon) to facilitate attendance.
- Interestingly, most members preferred to have the events held in a University Meeting Room, rather than at cafes/restaurants, and all members would be happy to contribute \$10 or less to an event.
- Some members suggested organising a networking event (without a speaker)

so that fellow PAIG members can introduce and get to know each other.

Our first meeting of the year was held at Latrobe University, City Campus in March. A panel discussion was held on the "Ten things I wish I had known about older people!" Our panel included clinicians, researchers and advocates with diverse expertise, each of whom talked about things that they wish they had known earlier in their careers.

Our May meeting was held at Monash University, Caulfield Campus. The topic was "What do older people really think about retirement housing?". Jayne Maini, Director and Placement Manager at Millenium Aged Care Placement Consultants, Rob Taft, a resident at Rylands in Kew, and Mark Silver, a social worker with Uniting Aged Care, presented a wonderful insight into the issues surrounding housing in later life, from retirement to residential care.

"Recent advances in clinical work with older people" were discussed at our recent September meeting. Dr Sunil Bhar, Senior Lecturer in Psychology at Swinburne University, discussed "Counselling older adults in university psychology clinics: Why, how and where?". His talk was prefaced by a brief presentation by Associate Professor Roger Cook, who gave a retrospective account of the Swinburne psychology clinic and its proposed direction for servicing older adults. Our third speaker, Alissa Westphal, an Occupational Therapist working with people with dementia, unfortunately became ill at the last moment and we hope to have her present at our end of year meeting in November. We were very grateful to Mark Silver for stepping in and presenting the very interesting results of his recent study on an emotional wellbeing project., which included excerpts from video footage of a men's carer support group.

We look forward to our end of year meeting in November, at which Heather Birch will be presenting on "Dementia: Lesbians and Gay Men". We hope Alissa Westphal will also be able to join us. The date and location of this meeting will be confirmed via email to members and associates shortly. Attendance at our quarterly meetings has been steady with a range of speakers covering neuropsychology, theoretical issues and clinical practice.

Due to an unavoidable clash, the August 2009 meeting was postponed until November when Valorie O'Keefe from Pearson presented a two-hour overview of the WAIS/WMS IV with a focus on changes that will benefit the assessment of older adults. The test materials and booklets were made available for viewing. In February 2010, Valorie O'Keefe, returned to present us with the new Advanced Clinical Solutions material relating to the WAIS IV and WMS IV. This was followed at our May meeting by a very interesting talk from Sue Ferguson of Macquarie University on theories of successful ageing and their implications for clinical work with older adults. Deborah Koder was elected as the new NSW convenor and we thanked Michael McMahon for his many years of hard work leading the group, ably assisted by Jane Turner who presented her review work on behavioural gerontology at the International Congress of Applied Psychology.

We hope to host a half-day workshop some time next year and promoting clinical placements within our aged care settings is another key aim of the group.
