Funded Supervision of Postgraduate Psychology Students in AOD Services

Are you interested in helping non-government alcohol and other drug (AOD) services increase their capacity to deliver on-site training? Are you interested in helping probationary psychologists gain effective AOD experience? The Australian Psychological Society (APS) is seeking expressions of interest from registered psychologists with demonstrated experience in clinical supervision of students working in the AOD field.

The APS is currently administering a clinical supervision scheme for postgraduate psychology student trainees to enable them to undertake

placements in non-government AOD services.

The scheme aims to develop workforce capability to deal with comorbid substance use and mental illness, by addressing the shortage of psychologists in the nongovernment AOD workforce.

This federally funded project will provide clinical supervision for postgraduate psychology students enrolled in Clinical, Counselling, Neuropsychology, Forensic and Health Psychology programs. Students will be required to attend the AOD service two days per week for twenty weeks.

Clinical supervisors recruited specifically for the project will be expected to deliver one hour per week of on-site supervision to participating student psychologists.

Clinical supervisors may also be funded to train and supervise staff of participating nongovernment AOD services on supervision days.

With the new Medicare numbers, many psychologists are reporting increased referrals from GPs where substance use is an issue. These are people who have not previously received specialist interventions. If you are seeing people now through referral from General Practice, please share those experiences.

The Commonwealth Government has recently provided funds to the NGO sector to increase the capacity of AOD services to better work with people with a comorbidity of mental health and substance use disorders.

Many of these organisations will now be seeking to employ psychologists to develop and lead these projects. Many jurisdictions will also be developing Headspace projects, which again will increase opportunities for psychologists. If you are involved in any of these new initiatives, please share your experiences through the newsletter.

Psychology and Substance Use Interest Group

The Psychology and Substance Use (PSU) Interest Group offers members an opportunity to engage with other psychologists who share an interest in substance use issues. The group aims to be of relevance to psychologists in a broad range of settings, including research, policy development, clinical work within the drug and alcohol system, and clinical work in other settings. We are always looking for ways the group can be of practical benefit to members, and we encourage members to become involved in whatever way they can. One important way is through the establishment of PSU groups in each jurisdiction—so if you are interested in bringing a group together in your area, we are keen to support you and provide help through the provision of seeding grants.

AGM SUGGESTS CHANGES FOR PSU contd. from P.1

With comorbidity of mental health and substance use disorders (or cooccurring disorders) the EXPECTATION rather the EXCEPTION, the need to increase the focus of the PSU was suggested to members attending the AGM.

Members also considered the fact that there is no Interest Group devoted to Mental Health issues, although mental health is clearly a focus at College level.

Any changes to the Terms of Reference for the Interest Group need to be submitted to the Board for approval, and would need to be accepted prior to this by PSU members. The suggested changes to the Terms of Reference are outlined below:

- I. To facilitate communication among psychologists interested in substance use and mental health issues.
- 2. To promote professional activities and practice, information sharing, research and discussion related to the psychology of substance use **and mental health**.
- 3. To provide a network of APS psychologists able to respond, as deemed appropriate by the APS, to emerging issues related to substance use and mental health.
- 4. To promote the role of psychologists as practitioners, researchers and commentators in relation to substance use **and mental health** issues.
- 5. To generate and maintain links with organisations that have a focus on

psychology, substance use **and mental health issues** within

Australia and internationally, who are congruent with the aims of the APS and the Interest Group.

A number of name changes were discussed to reflect the change of focus, and included:

- Psychology, Substance Use and Mental Health Interest Group (PSUMH)
- Psychology and Co-occurring Disorders Interest Group (PCOD)

The first was considered preferable as it did not appear to limit the focus to comorbidity alone.
